Terms and Conditions:

- The Visa fee is QAR 200 (non-refundable)
- Passport must be valid for at least 6 months from the arrival date
- Minimum 7 working days are required in order to obtain the visa
- Visa applicant must have a guaranteed reservation in the hotel
- Tourist Visa is valid for 30 days of stay from the date of entry
- Tourist Visa is a single entry visa and cannot be extended
- Overstaying is against the law and may result in imprisonment
- Guest must enter the country within the validity of the visa
- Visa applicant must carry QAR 5000 or other currency equivalent by cash or by credit card ("show money" at the immigration upon arrival at Doha International Airport)
- A refundable deposit of QAR 5,000 must be paid as a guarantee by cash or bank transfer or credit card.
- Deposit amount will be refunded once the guest exit from the country.
Note: Credit Card Refund may take up to 30-working days or more.
- Ramada Encore Doha will be applying for a Tourist Visa. Hotel acts as a facilitator only and delay / rejection of visa is not its responsibility
- Return flight ticket copy must be enclosed with the application form
- Guest must travel only upon receiving the visa and carry a copy while in Qatar.
- Guest must stay entirely at the hotel while in Qatar
- All necessary payment and documents must be provided in advance
- The visa process will begin once we receive all relevant documents along with the clear color passport copy
